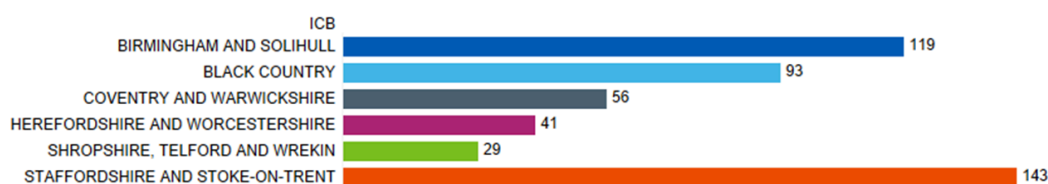

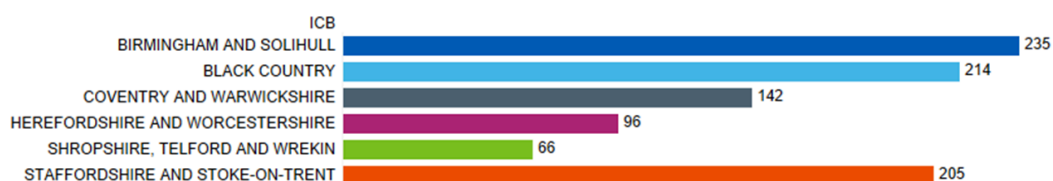
**Contractors are reminded that all Pharmacy First pharmacies must be delivering the Contraception and Blood Pressure Check services by 31st March 2025. The LPC expects at this stage, that activity (claims) will be the measure of "delivery".....not just signing up to the service.**

The latest available data indicates that around 40% of West Midlands contractors are actively delivering the Contraception Service; 80% of contractors deliver clinic BP Checks and 50% deliver ABPM checks.

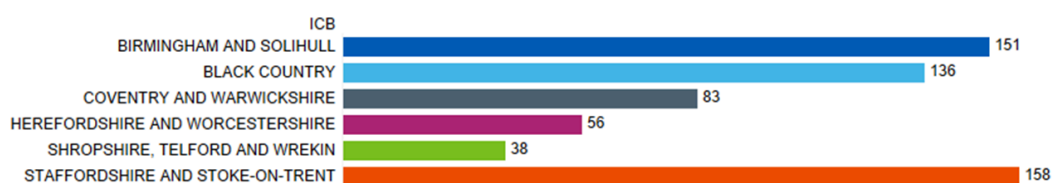
#### Number of active dispensing pharmacies within **West Midlands** for **Oral Contraception** since December 2023
