The update from the 24<sup>th</sup> October 2024 CPE/LPC Ops Team (CLOT) meeting to be shared once received.

The BSOL queries from the last meeting had been escalated to Jas heer or CLOT:

• NHS Services – payment lag – CPE are working with NHSE to see if they can

expedite payments in similar way to Rx payments going forward

- IPA CCA representation timelines for movement from proposed observers to final membership
  - Good response to EOI for the 2 observer places selection being looked at and hope to be in place during November. This interim arrangement in place for 12 months whilst long term solution and required gov changes and consultations – a road map will be produced and LPCs will be consulted.

Members were updated on the Conference of LPC representatives on 7<sup>th</sup> November meeting in London by JB RB AP SP. The slides from the day to be shared once released JB

Members were keen to seek prompter payments for services claimed via MYS, as there is no good reason not to pay by the end of the month.

And members were keen to understand the roadmap for the additional observers at CPE to become full members and to understand the interest in the EoI.

# 5. LOCAL COMMISSIONED ENHANCED SERVICES

# CGL

The snapshot of activity was reviewed from the 18<sup>th</sup> October meeting with Kevin It was noted that BCC has come back to CGL with a £40 fee for the Buvidal pilot. Discussions are ongoing

#### Umbrella

A frank exchange with the new Service Manager for Umbrella- Mr Lee Betteridge-Lyness was reported, and a little more optimism that the declining activity might result in a fee review for some remaining key services.

The Q1 & Q2 activity summaries were shared at the quarterly review on 8<sup>th</sup> Oct It was noted a continued reduction in overall activity primarily driven by lower OC activity and linked to increased activity of the NHSE Contraception Advanced Service.

#### Smoking (Birmingham)

Members received the update from 13<sup>th</sup> November quarterly meeting with BCC The Smoking Prevalence data from BCC was shared

The late payments issue from BCC to remain on the agenda as more delays in Q2 are predicted and attributed to pharmoutcomes <> BCC IT interface issues

## NHSE funding - MOU

Members noted the LPN payments now received for 23/24 and 24/25. MOU requires specific workplan to be agreed with LPN Chair (Satyan Kotecha)

## NMS

Members received the SDO tracker and graph for July 2024
And noted: 11444 NMSs delivered (best ever again) from 266 contractors (+51% v LY). Top performers (>150): Nationwide, Soho, Laser, Vesey
Overall occurrence rate of 0.5%, with just 13 contractors delivering >1% of items
NB 1% is the claiming ceiling per month (significant lower than June 24)
Just 38 with zero activity (lowest)

## DMS

Members noted no significant activity from B Sol trusts 4 DMS (3 completed) (Aug)

Jeff Aston – with his UHB hat on updated members. The PEN test and queries have been answered so the trust is happy to use PharmOutcomes as this CP System for the Smoking Discharge service. Their IT mobilisation plan is also progressing so UHB should be in a position to start DMS referrals in the new year. The committee reminded Jeff Aston that there would need to be a mobilisation plan to (re)launch the service across B Sol contractors in the New Year, once their process is confirmed.

# Autumn vaccination services

Members received the NHS Midlands CP system flu activity update summary. And noted B Sol contractor activity was lower than other systems. Chief Officer to seek to understand/explain the low figures, testing both PharmOutcomes AND Outcomes for Health (co-admin with Covid) are all captured in the report.

## NHS Hypertension Case Finding Service

Members received the SDO tracker and graph for July 2024 And noted: 6788 Bp checks claimed in the month (+11% v LY) Top performers: Erdington DN, Jhoots, Northbrook.

459 ABPMs claimed (+84% v LY) and an occurrence rate of 8% The SDOIs were seeking to understand high Bp and no/low ABPMs Ahead of further NHSE scrutiny.

201 participating contractors. Top performers: Shelley's, BSB, Beeches

Members also received the quarterly contractor activity comms for BP/ABPM

## NHS Smoking Cessation Advanced Service

Members received the SDO tracker and graph for July 2024 And noted: 15 claims for the advanced service in the month by 5 contractors A slow increase

The draft postcard to support comms to contractors is almost approved by UHB

# Contraception

Members received the SDO tracker and graph for July 2024 And noted: 781 on-going contraception claims from 98 contractors (top Oaks, BSB)

And 139 initiations from 53 contractors (Oaks)

The Chief Officer updated members on the issues with EPS nominations being changed without patient consent and the standardisation of the complaint's procedures for patients. Contractors to be aware of the GPhC (Regulate) comms and OWM comms. CPE (Gordon H) have been kept informed. After the LPC meeting, JB with a contractor impacted spent some time with NHSE OWM Rebecca Woods and Darren Plant and successfully made them aware of numerous nomination complaints by patients which needed to be "joined up". Further meetings planned.

Members welcomed Dr Jheeta from BLMC who provided candid updates from the GP representative committee, including possible collective action and the ICB's ESO as it impacts patient access (Pharmacy First)

KB demonstrated CP B Sol's website highlighting "new" & "changes" incorporated Which were well received by members. Other developments planned to continue.
