4. CPE MATTERS & FUNDING

Members received the updates from the 13th & 27th Feb CPE/LPC Ops Team (CLOT) meetings. And noted these are confidential notes shared with LPCs and Chief Officers <u>only</u>

The CO shared responses to February's queries:

Two other LPC items referred to Dan as IT related – NHSAPP (see MAPCOG info) and Proscript wholesale nomination change issue PPV – Gordon response – in a nutshell all main services have retain info for 3 years apart from the old delivery one which didn't specify. NHSE and Appeals have sided with commissioner on the delivery one that onus on contractor to retain and not destroy without asking permission from NHSE first! NHS writing to some contractors where may be some investigation to ask to retain documents for longer e.g. NMS. If asked you must retain longer. If fraud is suspected then NHS can go back as long as they need to, otherwise generally they will not go back further than the 3 years that should all have records for. The short answer is no we cannot insist that stop investigating after 3 years as it is in ToS so CPE not consulted.

Members received:

a contractor's bundle check report (underpayment of £26 in £191k) CPE's 25/26 LPC's levy presentation slides from February's CPE Board meeting (Jas's) the March/April CPE important dates tracker (already shared with contractors)

Members noted: Liam Byrne MP planning to visit a pharmacy in April

SS/JB

Jas updated members following the speculation about the CPCF negotiations. It is important to respect the confidentiality of the comments and speculation should NOT be fuelled by this discussion. It was clear that the outcome of the negotiations would be public soon.

-CPE recognised the frustration being voiced by contractors

-the IER (economic review) is NHSE's and so THEY are in control of when/how it is shared. However, this review was shared with the NT and the contents were not contested by the DHSC. It will be shared once outcome of negotiations is public. There is a feeling the new government grasped the fragility of the CP network. The settlement will cover off 24/24 & 24/25 with a direction of travel/plan for 2026 onwards taking into account the 3-year spending review

5. LOCAL COMMISSIONED ENHANCED SERVICES

Members were updated and commented on locally commissioned services from:

CGL

SP provide a verbal update following 14th February catch up with Kevin The snapshot of activity was shared - monthly income from all services stabilising at c £50k pm Contractors can claim any OoD THN if they expire before use Contract update from Kevin (contract is out for re-tender): At the moment it looks like we will be issuing a 6-month extension letter whilst awaiting the outcome of the tender process in Birmingham. Likely to be doing this early next week

Umbrella

Catch up meeting with new service manager, Lee. It would seem the BCC<>UHB head contract has now been agreed and is just awaiting all the signatures to be added. This should lead to the subcontracting arrangements to be shared with contractors. There is still a +2% fee increase each year meaning the EHC fee is likely to increase from £12.24 to 12.48 which is not recognising the cost of providing the service. RB supplied some additional update in her report and there was a steer from Jas to do nothing yet

Smoking (Birmingham)

Members received the BCC Smoking T&F Group presentation from 20th February. Year 2 plans for the Tobacco Control Grant (impacting CPs) were highlighted and the expectation that delivery fees would be added to the postal voucher service and training for varenicline (initially) and cytisine would be needed together with CV. Other local authorities had linked Rxs from GPs for varenicline with behavioural support from CPs JH>JB

The CO provided a verbal update on Q3 review meeting on 12th March – share presentation with minutes

The CO provided a verbal update from 6th March MBC session (ABL and smoking) Low impact and no action

Healthy Dialogue arranged first steering group meeting on 20th March where dates and plans were shared. It was agreed there would be NO contractor survey and this information would be sourced from the relevant organisations. Exec to continue to represent the LPC **RB JB**

7. NHS ENGLAND MATTERS

NHSE funding – MOU

LPN payments now received for 23/24 and 24/25. MOU requires specific workplan to be agreed with LPN Chair (Satyan Kotecha). Joint BC & B Sol bi-monthly meetings planned with LPCs COs & Chairs, CPCL and LPN Chair. The initial focus will be on promoting sign-ups to the NHS App which will have operational efficiencies to contractors' workload by decreasing telephone queries from patients re "order my next repeat", "are my medicines ready to collect?", "I ordered four items and have only received three" etc. All these features will become available to patients in 2025. The challenge is to get the patients to sign up and able to use the App.

<u>NMS</u>

The SDO tracker and graph for Nov 2024 was shared. Members noted: 12340 NMSs delivered from 275 contractors (+37% v LY). Top performers (>160): Northbrook, Laser & Vesey Overall occurrence rate of 0.5%, with 10 contractors delivering >1.1% of items NB 1% is the claiming ceiling per month Just 29 contractors with zero activity

DMS

No significant activity from B Sol trusts 18 DMS (16 completed) (BW Healthcare) Meeting with MMUH & Sandwell LPC & CPCL re DMS arranged for March Update in April

Autumn vaccination services

The SDO tracker and graph for Nov 2024 was shared. Members noted: 11572 flu jabs clamed in second full month Season to date = 63855 (+0.6%) v S, O & N LY Top performers (>600): Ashfurlong. & Walmley

Members also received the market stimulation presentation for RSV + Pertussis. NHSE are going out to tender in 3 systems inc 22 localities in B Sol. This is a new **NES** which is an important commissioning development for CPs. Webinar arranged c 60 attendees. Laboured procurement Return date extended to 31st March following feedback on timelines

NHS Hypertension Case Finding Service

The SDO tracker and graph for Nov 2024 was shared. Members noted: 7328 Bp checks claimed in the month (+38% v LY) Top performers (>500): Glebe, Erdington DN 84 zero activity contractors 609 ABPMs claimed (+107% v LY) and an occurrence rate of 8.3% (pleasing increase) 207 zero activity contractors Top performers (>50): Shelley's & BSB

Members also received the contractor 1-pager (shared already)

NHS Smoking Cessation Advanced Service

The SDO tracker and graph for Nov 2024 was shared. To note: ZERO activity

134 contractors NOT signed up top provide the service 169 contractors signed up with 21 active in 23/24 and 14 reporting activity just in 2024

Contraception

The SDO tracker and graph for Nov 2024 was shared.

Members noted: 980 on-going contraception claims. Top Performers (>100) Oaks, 54 zero activity (from contractors signed up) And 183 initiations from 68 providers. Top Performers (>10): Oaks) There are 239 contractors signed up to this advanced service of which 144 are active

Explanation of the latest UHB DMS fudge – 7 pilots to explore pathway with test patients

Members noted the CMO meeting provisionally booked in March with JB, RB, Clara Day & Paul Sheriff had been postponed. New date arranged

9. CHIEF OFFICER'S REPORT

Members were updated on the issues with EPS nominations being changed without patient consent and the standardisation of the complaint's procedures for patients.

Outcome of meeting to be chased. Some contractors are now receiving GPhC letters

The review of additions to the CP B Sol's website was deferred

10. CHAIR'S UPDATE

A copy of the email RB > JW (CPE) was shared Something to highlight as I wasn't aware that this could happen and may be something for Vicki to be aware of when she's settled in.

As you know Jeff and I have been banging the drum for increasing the Umbrella (University Hospitals Birmingham) funding for community pharmacies. Our conversations with their new contract manager has included presenting evidence that contractors are no longer providing the Umbrella ongoing contraception service, as the NHS service compensates more suitably to deliver it – which they agree on.

Meeting with the contract manager last week, our reasonable request to see some of the ongoing contraception budget transferred to the emergency contraception budget (currently £12.24 per consult) has been rejected. The reasoning of all this now has been shared, that although Public Health funding is ring-fenced with the council (Birmingham City), once UHB won the tender that ring-fencing is removed, so in this case, there is no more money for community pharmacy as UHB finance have earmarked it for elsewhere in the Trust. There are no quantitative KPIs for UHB as part of the council's tender, only qualitive – which doen't help steer community pharmacies to challenge back.

Obviously, I'm aware that if community pharmacies are subcontracted it starts to reduce the funding dripping through as the main commissioner needs to cover their costs, so we prefer direct commissioning however, this amazed and disappointed me!

Be good to get any thoughts from CPE.

Other points from RB:

CGL - are issuing a 6-month extension letter whilst awaiting the outcome of the tender process in Birmingham (Boots now received for 6 months)

DMS - it's not really clear what the impact of the 18 months of conversations have had on the pilot, still likely to cause barriers for some contractors, those that sign up and can start to receive referrals, please let us have feedback so we can consider next steps

11. GOVERNANCE

The new member election process was in progress with 3 independent contractors expressing an interest. The vote close 24th March

12. FINANCE
