## Pharmacy First Activity

Further to our previous communication, we remind you that the [Primary Care Hub](#) provides resources to support all Primary Care Access Recovery Plan (PCARP) services, including **Pharmacy First**.

### Feedback from GPs

Some pharmacists are not always accepting referrals for minor illnesses as part of the Pharmacy First service (The old CPCS conditions).

### Reminder

If you see a patient and complete a consultation in the consultation room, this qualifies for the Pharmacy First minor illness consultation fee.

**⚠️ This will not contribute to the Clinical Pathway threshold, but a £17 activity fee is still claimable.**

### PF Payments & Thresholds

#### **Consultation Fee (from 1st April 2025)**

£17 for Minor Illness and Clinical Pathway consultations.

£15 for Urgent Supply consultations.

#### Monthly fixed payment

In addition to the consultation fee, pharmacies that meet the Clinical Pathways consultations threshold will be eligible for a monthly fixed payment:

**£500** --> 20–29 Clinical Pathway consultations claimed within a month

**£1,000** --> 30 or more Clinical Pathway consultations claimed within a month

### Eligibility requirements

To qualify for the fixed payment pharmacies must be **registered** and **able** to deliver the Hypertension Case Finding Service, the Pharmacy Contraception Service (PCS) and the

Pharmacy First service, in addition to meeting the Clinical Pathway consultation thresholds outlined above.


