NHSE Weekly Meeting (MAPCOG)

Members received:

-the MAPCOG meeting notes from 20th May And noted spring Covid vaccination activity (B Sol disappointing) together with EPS nomination complaints

- -the PhIF update (IP and PCARP) meeting notes
- -the PCARP ranking report for January 25

8. ICS DEVELOPMENT

SA provided members with the ICB update. Highlights included:

- -GPs represent 22% of PF referrals in May.
- -<80% of clinical pathway consultation resulted in an antibiotic supply
- -PF posters printed to include a QR code for onward supply to GPs & CPs
- -further engagement with Healthwatch, UTCs and at locality meetings

- -routine comms to schools & colleges via BCC's network and to be repeated in the summer term and then again in September
- -UTC exploring buying PO license as part of winter planning to facilitate referrals
- TPP (System 1) will soon have their integrated solution (impacting c1/3rd of GPs)
- -PF PO licences to be funded nationally so any refund will be used to buy F12 referral Button for Bp & contraception service referrals
- -new GP consultation tools need to be available for all GP opening hours from Oct 25 (GP contract). (eg Rapid health, Blinx). The challenge is to ensure there is a PF pathway embedded in the software.
- -H2 use GP Connect provided in delegate pack on 8th June (to support any CP conversations)
- -Know Your Numbers (Bp) will be a key social media theme in September
- part of the ICB Website (at the moment accessible by GPs only). Support shared (but need to seek access for CPs)
- -DMS; UHB system still being piloted (slowly). LPC reservations remain re transfer of information
- -IP Pathfinder sites all active. 107 consultations in Q4, 100 in Apr & 84 in May

- -the ICB Blueprint paper (future)
