Pilot Overview

Community pharmacy sites participating in the pilot will:

- Deliver lipid PoCT alongside blood pressure monitoring
- Support both primary and secondary prevention pathways
- Participate in evaluation activities to inform future commissioning decisions
- The pilot is scheduled to run until 31 March 2027

Important Information

Contractors should review all available documentation carefully before deciding

whether to submit an expression of interest.

Please note:

Contractors need to read the available information ([attached](#)) and make a decision to express an interest to provide the service and submit it before 18th June. Barts will make the decision on which providers have been successful if there is an oversubscription.

Patients will need to have their BP measured as well and **IF** they are eligible for screening as part of the NHS Hypertension Service, this can be claimed too.

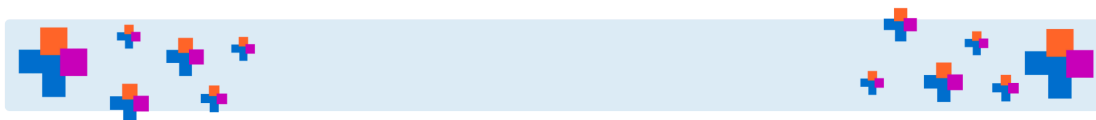
